The Use of cookies

Cookies are small text files that are placed on your computer by websites you visit and their main purpose is to let the website function more efficiently and to enable specific functionalities. They are used to improve the users entire web surfing.

Technical Cookie and grouped statistic cookies

Activities necessary for the functioning

This web-site uses cookies in order to save the Users session and to complete other activities strictly necessary to the web-site.

Preference activity management and statistics
